Admission agreement

In consideration of submission of

I/We being the parents / legal guardians of the Child do hereby jointly and separately agree to undertake with the SmartKids as follows:

Any changes to the Child's particulars will be advised in writing as soon as possible to SmartKids.

SmartKids will use its best endeavors to ensure that only the authorized persons listed herein are able to collect the Child from SmartKids.

I/We understand that whilst SmartKids will make all reasonable efforts to contact me/us in case of medical emergency, this is not always possible. Therefore I/we authorize SmartKids to seek medical advice and treatment for the Child if SmartKids believes there to be an emergency and I/we hereby undertake to pay all cost incurred.

I/We agree that the Child attends SmartKids at his her own risk. Unless found to be grossly negligent. SmartKids assumes that the child is normally covered by private medial insurance / accident insurance and SmartKids can not be held responsible for any injury that may occur to the Child while attending SmartKids. SmartKids will also not be liable for any loss or damage to the Child's personal belongings.
